



Security and Shipping Agreement

While we will do our best to minimize any inconvenience to our customers and industry partners, we are committed to the safety of the traveling public and will diligently carry out all of our responsibilities in order to ensure the security of the transportation supply chain. As such, we ask your cooperation on the following security and commerce related issues:

In accordance with TSA security regulations, and our Independent Air Carrier Standard Security Program (IACSSP) Section 2.2 H we are required to receive consent to screen cargo for any cargo that may be tendered on an aircraft or forwarded via airfreight. By signing and/or submitting this document, you consent from the date of signing forward, to allow your cargo to be searched, inspected, and/or screened by any method that Ezone deems necessary in order to comply with any State or Federal rules and/or regulations. This blanket document will remain on record with Ezone for at least 30 days after the termination of the agreement in writing by you and may be provided to the TSA for inspection. If you do not consent you understand that your cargo may be refused and/or held at our facility.

I understand the above statement and wish to allow/consent to screening of our cargo from this date forward

Furthermore you understand that Ezone must comply with federal regulations concerning U.S. Export Control and U.S. Border Protection and as such is required to file or confirm the filing of Electronic Export Information (E.E.I. formally S.E.D.) for any single commodity with a value of \$2,500 or greater contained within any single shipment. You hereby certify that any information or invoice that you provide for the purpose of such filing is true and accurate. Invoices or value statements are also required to prove value under \$ 2,500.
